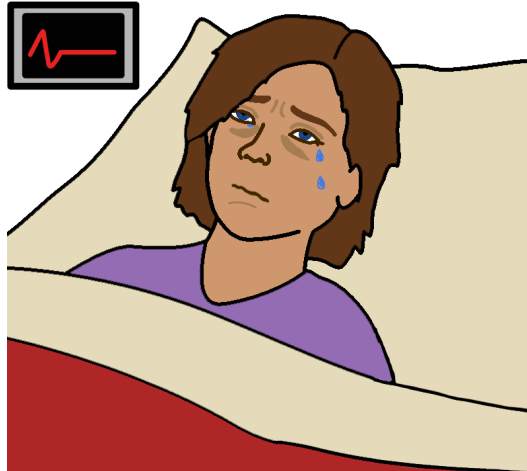

This book is about a new **law** to help people who are dying.

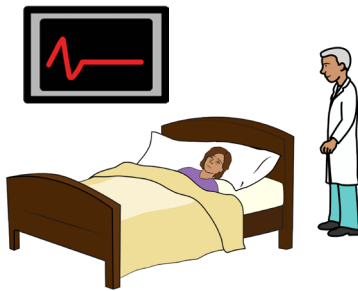
A law is a rule.

- how they want to.

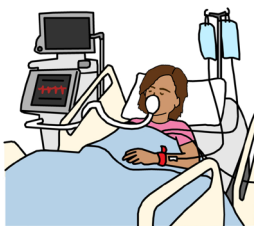

## Why do we need the new law?

Many people **suffer** when they are

- very ill
- about to die.



Suffer means you feel lots of pain.

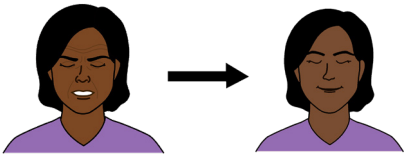


A person who suffers might

- be very upset that they will die



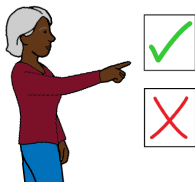
- feel a lot of pain in their body.



The new law wants to help people suffer **less** when they die.



People can get help to die how they want to in other places.



We also want to give some people this choice.

## What do we want to change?

We want to allow some very ill people  
to choose

- when they die
- how they die
- a person to help them
  - for example, a doctor.

**Not** everyone will be able to get help to die.

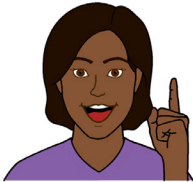


Some people will be able to get medicine that

You can tell us

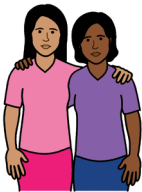
- your ideas on voluntary assisted dying

- a support worker.

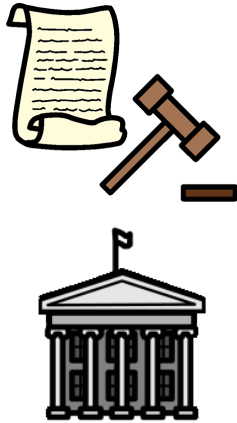
## What will happen next



After everyone has had a say, we will read what people think.



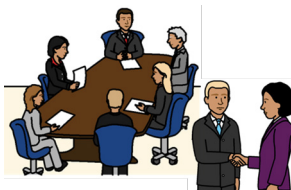
We will also ask experts what they think.

- send the new law to the **ACT parliament**.

The ACT parliament is a group of people who make laws in the ACT.

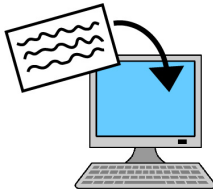
